Customer Satisfaction²

Unum pays billions in benefits. In 2017, Unum processed more than 620,500 new claims and paid \$5.8 billion in benefits in the U.S. Of those, over 424,000 were for disability coverage. A breakdown of our disability claims is as follows:

- 85% of all new disability claims submitted were approved and paid
- 15% were not eligible for benefits because of return to work or the terms of their policy
- Of these, 1% of claimants were denied based on the terms of their policy⁴
- Of the disability claims denied, 1% elected to appeal the decision

Our customers like doing business with Unum. During 2017, Harris Insights & Analytics asked nearly 1,000 of our employer customers to rate our company in the areas of overall relationship, claims processing and customer service. Among the results:

- 98% reported they are likely to renew their Unum group products
- 93% give us positive marks for overall quality of products/services and for overall value
- 91% give us positive ratings for being easy to do business with

Recent research conducted by Market Decisions found that people who have filed claims with Unum express high levels of satisfaction with the company:

- 98% of long term disability customers and 96% of short term disability customers rate our claims representatives as courteous and respectful
- 95% of voluntary benefits customers are satisfied with the overall handling of their Unum claim


Complaints³

Unum receives fewer complaints.

As reported by the <u>National Association of Insurance</u> <u>Commissioners</u>, Unum's 2017 complaint ratio of 0.39 for group accident and health products underwritten by Unum Life Insurance Company of America is **the lowest** against our primary competitors. NAIC publishes annual complaint ratios as reported by state insurance departments.

Complaint categories include underwriting, sales and marketing, claims handling and policyholder service.

Group accident and health complaints include those related to health insurance and short term and long term disability products.
